From Palm Springs: CA- I-10 east, keep to the right and take CA-86 Spur St. Via Exit 145, toward CA-86S Expressway (to Brawley/El Centro) turn slight right onto 62nd Ave., turn left onto CA-111, turn right onto Marina Dr., turn left onto Sea View Dr.

From Hemet and Temecula, Corona areas: Begin on 215 north, to CA-60 east toward Indio, merge onto CA I-10 east, keep to the right and take CA-86 Spur St. Via Exit 145, toward CA-86S Expressway (to Brawley/El Centro) turn slight right onto 62nd Ave., turn left onto CA-111, turn right onto Marina Dr., turn left onto Sea View Dr.
